Accepting the General Conditions:

As soon as you access the Site, whether from the MSF home page or any other page, the General Conditions are applicable.

MSF reserves the right to change or update the General Conditions at any time. Each new numbered and dated version of the General Conditions becomes applicable from the date it is uploaded to the Site.

You are therefore encouraged to regularly consult the legal notices and General Conditions in force when you access the internet Site, whether from the home page or any other page.

Accessing the Site:

Access to the Site is restricted to persons with an identifier supplied by MSF.

The Site is accessible at the URL address "<https://www.soukmsf.org>", 24/7, except in cases of major emergencies, IT system failures, maintenance operations, updates or issues linked to telecommunications networks.

Access to, information and services offered on the Site are free.

The identifier and password required to access spaces and services [on the Site] are strictly confidential.
